The IQAC in its 8th meeting held on 10/04/2019 planned for future to apply for various National/International rankings and in the follow up of the same the IQAC applied for the following National and International Rankings:

The University following National/International Rankings to its credit:

National Level:

1. The University was ranked at 21st in the India Today-MDRA in the Best Technical University category rankings 2020
2. The rankings for 2020 were declared on 18 Aug. 2020 and our University was rewarded with an '**Appreciation Letter**' and categorized as '**Band A**' Institution (rank between **6-25**) in category of '**Govt. and Govt. Aided Universities**' in Atal Ranking of institutions on Innovation Achievement (ARIIA) 2020. The rankings were jointly declared by MIC, MHRD and AICTE.

International Level:

1. **The Times Higher Education World University Rankings- 2021:** Guru Jambheshwar University of Science and Technology, Hisar (GJUST) has Established itself on World Level academic platform with securing 801 to 1000 rank band with overall score between 25.1 to 30.1 in the one of the globally prestigious **The Times Higher Education World University Rankings 2021 and the University was ranked between 601-800 rank bands in the subject category of Physical Sciences.**

In Teaching Sub Category the University had a score of 29.5 and with this score University was at 25th National level. In Citations Sub Category University had a score of 41.4 and was placed at 18th at National level. In Research Sub Category University had a score of 8.9 and in this Sub Category the University was at 51st place at National level. The University secured 19th place under Overall Category in India. At International level the University has been ranked at 481 in Teaching Category. There were 63 Indian institutes listed in this prestigious ranking and **GJUST was the only University from Haryana** ranked in this International Ranking. The University achieved this remarkable ranking in its Silver Jubilee year of establishment.

2. **UI-Green Metric World's Most Sustainable University Ranking 2019.**

The University secured 6th rank in the UI (Universitas Indonesia) Green Metric World's Most Sustainable University Ranking in India by the Universitas of Jakarta, Indonesia in

December 2019 and secured 321st rank in the world.

UI-Green Metric World's Most Sustainable University Ranking (2020): The University secured 12th rank in the UI (Universitas Indonesia) Green Metric World's Most Sustainable University Ranking in India by the Universitas of Jakarta, Indonesia in December 2020 and the University secured 445th rank in the world.
