
**The following agendas were also discussed and approved:**

- 1 The case regarding registration of three additional Research Scholars with Prof. B.S. Khatkar was discussed. As per the status in February 2019 (File No. FT/19/1330 Dt. 12-02-2019) five Research Scholars were registered and three Research Scholars were preparing synopsis for Ph.D. registration. In addition to these eight Research Scholars, Department of Food Technology has recommended that the seats may be increased so that one more Research Scholar may be registered under the supervision of Prof. B.S. Khatkar. As per latest status (in December 2019 File No. FT/19/969 Dt. 26-12-2019) there are six Research Scholars registered under the supervision of Prof. B.S. Khatkar therefore it was resolved that One additional Research Scholar beyond the limit of 08 research scholars, may be allowed by treating marginal increase which is allowed as per Ph.D. ordinance on the recommendation of the Vice Chancellor.
- 2 The research scholars of the University should publish research papers as per UGC-CARE list journals only.
- 3 An induction programme for newly admitted Ph.D. students will be organized on 22 Jan 2020.
- 4 It was resolved that One additional JRF may be associated as Ph.D. student with Assistant Professor/Associate Professor/Professor in addition to present limit of Ph.D. students i.e. 05 for Assistant Professor and 08 for Associate Professor/Professor.
- 5 It was resolved that the University library will subscribe only Scopus and UGC-CARE list journals.
- 6 The subscription of online Wiley Journals in the University library is recommended.

It is notified that while giving consent to act as Ph.D. supervisor, the faculty members should give preference in the following order: UGC/CSIR JRF, UGC/CSIR NET, GATE and other equivalent exams.
