Proceedings of the meeting of the Committee constituted to promote quality research, International Research Collaborations and to encourage researchers held on 16.11.2015 at 03:00 p.m in the Committee Room, office of the Vice-Chancellor

A meeting of the Committee constituted to promote quality research, International Research Collaborations was held on 16.11.2015 at 3:00 PM under the Chairmanship of Hon'ble Vice-Chancellor. The following members were present:

The following decisions were taken:

- I. A Research Promotion Board may be constituted to promote, encourage the research culture. The Research Promotion Board will take cognizance of the problems being faced by the teachers/researchers for submission of their proposals/projects to various Government agencies like SAP, FIST, DST etc. A committee of the following was constituted to frame the guidelines for Research Promotion Board:-
 - (1) Prof. S.C. Kundu, HSB

(2) Prof. Neeraj Dilbaghi, Director, IQAC

- (3) Dr. Sandeep Kumar, Asstt. Professor, Bio-Nano Technology
- II. It was decided to invite some well-known International researchers/experts under GIAN program and explore the possibilities with them for MoU or research collaborations for promoting Quality research. The proposals may be submitted to the coordinator GIAN, GJUST, Hisar. It was also decided to go for academic collaboration/ MoUs with the national/International institutions of higher reputation to enhance the Academic/Research quality.
- III. The teachers who attend research training/visiting Professorship may be allowed special academic/duty leave to encourage them to conduct high level research. It was also decided some senior active eminent scientist of country/abroad may be given honorary/emeritus/visiting professorships.
- IV. It was also decided that University may earmark some funds for the purpose of research. These funds may be provided from the University itself besides other agencies.
- V. It was also decided that a committee consisting of Prof. Devinder Kumar, Coordinator, CIL, Prof. Neeraj Dilbaghi, Prof. Ashish Aggarwal, and Dr. Munish Ahuja may be constituted to pursue/apply for PURSE grant of DST.
- VI. It was further decided that In order to motivate outstanding research, appreciation letter may be issued to the faculty members who have been awarded national/International awards or who have contributed publications in high impact journals.
- VII.In order to simplify purchase cases (e.g. issue of (P.G.B) performance bank guarantee came up) and it was decided to constitute a committee for a revision of purchase guidelines/rules as per State Government rules and the reports of the committee be placed to the appropriate bodies for approval.

- VIII. It was further decided that the Chairpersons of all teaching departments may be requested not to send the Students/JRF/Project Fellows to the Audit Branch for their salary/ Contingency/Project bills. The relevant administrative Staff may be deputed/ assigned the duty for the purpose by the Chairman.
- IX. It was also decided to amend the rules for attending seminars/conference and providing financial assistance to the teachers by taxi/own car as per their entitlement.
- X. It was also decided to explore the possibility of faculty exchange programme with various organizations of national and International reputation.
- XI. It was decided that entitlement/eligibility for guiding Ph.D Scholars be increased to 5, 8 & 8 for Assistant professors, Associate Professors and Professors respectively from current session. Also, it was resolved that NET qualified candidates be exempted from Ph.D entrance Test as per UGC rules.
- XII. The committee also decided to Introduce One Guru Jambheshwar Post-Doctoral fellowship in each department from next academic year. The eligibility, amount of fellowship and other modalities/Terms and conditions will be framed by a committee constituted by the Vice- chancellor.
