 - e) Rs.5 Lac may be allotted for the procurement of the equipments for B.Sc. (H) Physics as proposed by the Department of Physics.
 - f) For the Department of Mechanical Engineering, 01 Lab Technician on contract may be appointed having the qualification proposed by the department.
