- 1 The outside expert/faculty member/scientist who are associated as co-supervisor for carrying out Ph.D. work by the research scholars of GJUST should obtain NOC (No Objection Certificate) from his/her employer before giving assent to become co-supervisor for GJUST research scholar.
- 2 GJUST faculty members will obtain NOC from the University before giving their assent to become co-supervisor for Ph.D. students registered in other institutes/universities.
- 3 For the evaluation of Ph.D. thesis, six examiners are recommended by PGBOS&R of the respective department. No examiner should be from the institutes / universities located in Hisar. There should not be more than 2 examiners from the institute/Universities located in Haryana. One of the examiner should be from centrally funded institutes including IITs/NITs/IIMs/Central Universities/National Labs / CFTIs etc.
- 4 At present, the synopsis of the Ph.D. thesis is first recommended by departmental research committee. During the meeting of DRC whenever there is synopsis presentation, it will be in the presence of Dean of concerned faculty and Vice-Chancellor or his/her Nominee.

5 SCI-Finder should be purchased in the Dr. APJ Abdul Kalam Central Instrumentation Laboratory as it will benefit hundreds of students of various departments from the budget of CIL.
